CFCU Payment-Free Summer Sweepstakes Official Rules

Contest is open to all individuals. No purchase or payment is necessary to enter or win this contest. A purchase will not increase your chances of winning.

CONTEST PERIOD:

The contest begins at 8:00 am EST on Saturday, June 1st, 2019 and ends at 12:30 pm EST August 31st, 2019.

ELIGIBILITY:

In order to be eligible to participate in this Contest, the entrant must be eligible for membership with Chesterfield Federal Credit Union. There is no requirement that you become a Chesterfield Federal Credit Union member, purchase goods or services, pay any money or submit to any sales promotion to be eligible to participate, and none of the above will increase the odds of winning. The Contest is open to legal residents of the 50 United States and the District of Columbia, who are 18 years of age or older, unless expressly limited or prohibited by applicable state law. Employees, Volunteers or Board of Directors and their immediate family members (parents, children, siblings or spouse, regardless of where they live, or persons living in same household, whether related or not) of Chesterfield Federal Credit Union are not eligible to participate. The Contest is void where otherwise restricted or prohibited by law.

HOW TO ENTER:

You will automatically receive one entry into the giveaway when you close on a vehicle loan from Chesterfield Federal Credit Union during the Contest Period. A vehicle loan is a loan using a car, boat, motorcycle or RV as collateral. Limit one entry per loan. There is no limit to the number of entries a member may have.

ALTERNATIVE METHOD OF ENTRY:

Your entry will be entered into the weekly drawing only during the week it was received, and it will be entered into the monthly drawing only in the month it was received. Limit one alternative method of entry per month per eligible member.

DRAWING:

On or about Monday, June 10th, 2019 and weekly thereafter, weekly winners will be selected from all eligible entries received during the previous week.

On or about Monday, July 1st, 2019 and monthly thereafter, monthly winners will be selected from all eligible entries received during the previous month.

On or about Monday, September 2nd, 2019, a grand prize winner will be selected from all eligible entries received during the contest period.
