Who is eligible?

- Applicants must have an account at Susquehanna Valley FCU and be a member in good standing.
- The applicant must be currently enrolled or pending enrollment in an accredited postsecondary educational program, taking at least six credits.
- Applicants may win one time only for each the Volunteers and Larry L. Stoner Scholarships, and no more than two years total.
- Employees, volunteers, and immediate family members of employees and volunteers of Susquehanna Valley FCU are ineligible for the scholarships.

Timeline:

- All applications must be postmarked no later than February 28, 2019.
- March, 2019 – Scholarship winner will be notified.
- April, 2019 – Scholarship presentation at SVFCU's Annual Meeting.

Payment:

The scholarship funds will be mailed directly to the school upon successful completion of one semester. If the recipient is currently enrolled in post-secondary education, they may provide a transcript from the previous semester and the funds will be disbursed for the upcoming semester without waiting.
